CONSOLIDATION OF OIL AND GAS LEASES

WITNESSETH:

This Consolidation of Oil and Gas Leases is executed by Devon Energy Production Company, L.P. ("Lease Owner") to establish a pooled 627.60-acre oil and/or gas unit as follows:

WHEREAS, Lease Owner is the owner of the following described oil and gas leases insofar as they cover land in Ashland County, Ohio:

Item 1: (DEPCLP Lease No. 34-3000263-000) - Lease dated April 16, 2008, by and between David E. Eichelberger and Diana Eichelberger, husband and wife, as Lessor, and WRP Energy Services, LLC, as Lessee, covering 160.00 acres of land, more or less, situated in Section 16, Township of Clear Creek (T25N - R17W), Ashland County, Ohio, and being recorded in the Official Records Volume 608, Page 471, in the Recorder's Office, Ashland County, Ohio; and any extensions, revisions, amendments and/or ratifications thereto.

The lease described above being hereinafter referred to as the "Eichelberger Lease" (Parcel No. A01060000600).

Item 2: (DEPCLP Lease No. 34-3000264-000) - Lease dated May 9, 2008, by and between David W. Crist, a single man, as Lessor, and WRP Energy Services, LLC, as Lessee, covering 17.40 acres of land, more or less, situated in Section 16, Township of Clear Creek (T25N - R17W), Ashland County, Ohio, and being recorded in the Official Records Volume 607, Page 955, in the Recorder's Office, Ashland County, Ohio; and any extensions, revisions, amendments and/or ratifications thereto.

The lease described above being hereinafter referred to as the "David Crist Lease" (Parcel No. A01060000101).

Item 3: (DEPCLP Lease No. 34-3000265-000) - Lease dated May 9, 2008, by and between Wayne and Elizabeth Crist, husband and wife, as Lessor, and WRP Energy Services, LLC, as Lessee, covering 141.00 acres of land, more or less, situated in Section 16, Township of Clear Creek (T25N - R17W), Ashland County, Ohio, and being recorded in the Official Records Volume 608, Page 511, in the Recorder's Office, Ashland County, Ohio; and any extensions, revisions, amendments and/or ratifications thereto.

The lease described above being hereinafter referred to as the "Wayne Crist Lease" (Parcel No. A010160000100).

Item 4: (DEPCLP Lease No. 34-3000543-000) - Lease dated June 5, 2008, by and between James and Judith Bernhard, husband and wife, as Lessor, and WRP Energy Services, LLC, as Lessee, covering 102.00 acres of land, more or less, situated in Section 16 and 14, Township of Clear Creek (T25N - R17W), Ashland County, Ohio, and being recorded in the Official Records Volume 608, Page 43, in the Recorder's Office, Ashland County, Ohio; and any extensions, revisions, amendments and/or ratifications thereto.

The lease described above being hereinafter referred to as the "J. Bernhard Lease" (Parcel No. A010160000300).

Item 5: (DEPCLP Lease No. 34-3000521-000) - Lease dated June 5, 2008, by and between Timothy and Deborah Bernhard, husband and wife, as Lessor, and WRP Energy Services, LLC, as Lessee, covering 90.00 acres of land, more or less, situated in Section 16, Township of Clear Creek (T25N - R17W), Ashland County, Ohio, and being recorded in the Official Records Volume 607, Page 951, in the Recorder's Office, Ashland County, Ohio; and any extensions, revisions, amendments and/or ratifications thereto.

The lease described above being hereinafter referred to as the "T. Bernhard Lease" (Parcel No's. A010160000401 and A010160000200).

Item 6: (DEPCLP Lease No. 34-3000314-000) - Lease dated April 1, 2008, by and between Nevin and Eileen Hoover, husband and wife, as Lessor, and WRP Energy Services, LLC, as Lessee, covering 157.00 acres of land, more or less, situated in Section 16, Township of Clear Creek (T25N - R17W), Ashland County, Ohio, and being recorded in the Official Records Volume 608, Page 10, in the Recorder's Office, Ashland County, Ohio; and any extensions, revisions, amendments and/or ratifications thereto.

The lease described above being hereinafter referred to as the "Hoover Lease" (Parcel No. A010160000501).

WHEREAS, pursuant to the rights and powers granted in the above described leases, as the leases may have been amended, Lease Owner desires to establish a 627.60-acre oil and/or gas unit consisting of the above described leases, insofar only as they cover and apply to oil and/or gas produced from all oil and/or gas sands and formations found between the stratigraphic equivalent of the top of the Queenston Shale formation down to the top of the Ordovician Gull River Limestone formation in and under the following described 627.60 acres of land:

Tract 1: 160.00 acres of land, more or less, being all of the lands covered by the "Eichelberger Lease".

Tract 2: 17.40 acres of land, more or less, being all of the lands covered by the "David Crist Lease".

Tract 3: 141.00 acres of land, more or less, being all of the lands covered by the "Wayne Crist Lease".

Tract 4: 62.20 acres of land, more or less, being all 102.00 acres of land covered by the "J. Bernhard Lease" SAVE AND EXCEPT 39.80 acres of land situated in Section 14, Township of Clear Creek (T-25N - R17W) Ashland County, Ohio, being more particularly described as all of parcel number A010160000300.

Tract 5: 90.00 acres of land, more or less, being all of the lands covered by the "T. Bernhard Lease".

Tract 6: 157.00 acres of land, more or less, being all of the lands covered by the "Hoover Lease".

The 627.60 acres of land herein included in this oil and/or gas unit are hereinafter sometimes referred to as the "627.60-acre pooled oil and/or gas unit";

In accordance with the terms and conditions of each of the aforementioned leases, the Landowners' royalty as therein provided shall be payable in the following proportions:

• Eichelberger Lease	160.00 / 627.60
• David Crist Lease	17.40 / 627.60
• Wayne Crist Lease	141.00 / 627.60
• J. Bernhard Lease	62.20 / 627.60
• T. Bernhard Lease	90.00 / 627.60
• Hoover Lease	157.00 / 627.60

NOW THEREFORE, Lease Owner executes this instrument as a Consolidation of Oil and Gas Leases pursuant to the powers to pool contained in the above described leases and declares that the above described leases, as the leases may have been amended, and all royalties, overriding royalties, production payments and reversionary rights thereunder, if any, insofar only as the leases cover and apply to oil and/or gas produced from all depths and formations found between the stratigraphic equivalent of the top of the Queenston Shale formation down to the top of the Ordovician Gull River Limestone formation in and under the 627.60-acre pooled oil and/or gas unit, are hereby pooled and combined and shall comprise a 627.60-acre pooled oil and/or gas unit.

There is attached hereto, as Exhibit "A", a plat of the land included in this 627.60-acre pooled oil and/or gas unit, the plat being for the purpose of assisting in the location of the 627.60-acre pooled oil and/or gas unit upon the ground in the event there is any inconsistency or insufficiency in the description hereinabove set forth of the land included in the 627.60-acre pooled oil and/or gas unit.

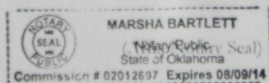
